



General Administration

eSubmissions

Speed up decision making by digitising your memos (submissions).

- Eliminates the issue of lost submissions and the delays that result from the transportation and dissemination of paper submissions
- Ensures the visibility of submission progress at all times
- Improves financial control through an up-to-date view of all available budgets and integration with the Basic Accounting System (BAS)
- Allows for all supporting documentation to be attached electronically
- Ensures that submissions can be viewed 24/7 through the web application, from any location and at any time
- Allows users to work offline and on the road using the tablet application that works across a variety of mobile devices
- Strengthens security and enforces security classification levels for additional peace of mind and regulatory reliability

DG Tasks & Resolutions Tracking

Sharpen your delivery focus with a systematic tool to register, assign, report and track strategic tasks.

- Registers, assigns and manages all tasks from one central point
- Delivers real-time visibility of progress using progress tracking dashboards
- Automates follow-ups on tasks that are overdue or running late on delivery
- Enables officials to report electronically on the progress of their assigned tasks and to attach a portfolio of evidence to support their work
- Automates the generation of acknowledgement letters and emails in situations where the tasks are in response to stakeholder communications

- Provides access to detailed audit trails to strengthen accountability in the case of delays
- Simplifies the co-ordination of responses to multi-part questions that require input from a multitude of Branches
- Allows users to attach any supporting documentation and information to their responses (such as a portfolio of evidence)
- Enables convenient searching and retrieval of all historical Parliamentary Questions and their accompanying responses

Subsistence & Travel Claims

Simplify the S&T claims and approval process to drive efficiency and speed.

- Significantly simplifies the submission of S&T claims
- Automatically calculates Allowance and Kilometre claim amounts based on pre-loaded Department of Public Service and Administration (DPSA) and Department of Transport (DoT) tariffs respectively
- Eliminates errors and delays that result from the manual calculation and verification of these claims
- Prevents the submission of claims when budget is not available
- Integrates seamlessly with the Travel Booking module to link expenses to previously approved travel requests
- Co-ordinates the end-to-end process of obtaining the necessary approvals and the capturing of claims into PERSAL in order to speed up the reimbursement of claims

Human Resources

Leave Management

Eleminate one of the most common sources of Audit Findings across government with an automated Leave Management solution that integrates with the Personal and Salary System (PERSAL).

- Prevents officials from applying for leave when insufficient credits are available
- Eliminates challenges around lost leave forms and the financial implications thereof
- Enforces compliance with the DPSA and Departmental Leave Policies, including the enforcement of mandatory documents, the 'Eight Week Rule', credits for special leave types and family responsibility, many of which are currently ignored by PERSAL
- Provides supervisors with the ability to recommend and approve leave, even while out of the office, thereby eliminating approval delays and the subsequent audit findings
- Allows for staff members without access to computers to apply for leave through their mobile phones or kiosks

PMDS

Improve compliance and performance by automating everything from planning, monitoring and review to appraisals for Performance Management and Development System (PMDS).

- Supports the capturing, reviewing and approvals of Work Plans and assessments
- Generates Work Plans in PDF format for easy filing and retrieval
- Makes submission and review of PMDS performance contracts and assessments as painless as possible thereby improving levels of compliance
- Allows for the attachment of a portfolio of evidence that can be used to substantiate reported performance levels
- Automates notifications and letters for Work Plans and assessments that are overdue
- Provides management reports and analysis that strengthens compliance, such as employees without an approved performance contract, or assessments that have not been completed within stipulated time frames
- Exports appraisals to Excel thereby feeding into other processes, such as the calculation of employee bonuses
- Consistently enforces the application of the PMDS policy whilst simultaneously shortening turnaround times

Strategic Planning & Reporting

Take the effort out of compiling and reporting against the Annual Performance Plan (APP) and Operational Plans (OPS Plan) and get an up-to-date and realistic view of progress made by the department against its strategic objectives.

- Aligns with the National Treasury planning framework
- Co-ordinates the compilation of the APP and OPS Plans with automated follow-ups and escalations
- Allows for the Strategic Planning unit to focus on providing strategic guidance and support instead of policing the process
- Enforces strict and timeous reporting based on the department's strategic objectives and in line with reporting cycles
- Requires that a portfolio of evidence be attached to substantiate reported performance thereby eliminating a common source of audit findings
- Reports against achieved targets as per the plans, any deviations and the recovery plans where necessary

Supply Chain Management

Supplier Management

Transform registering suppliers into an automated and simple system, which facilitates compliance with policy and legislative frameworks.

- Automates the supplier registration process
- Manages supplier commodities and areas of operation
- Automates verification against
 South African Revenue Services (SARS),
 Companies and Intellectual Property
 Commission (CIPC) and the National
 Treasury's supplier lists
- Aligns with the latest B-BBEE registration and compliance reporting requirements
- Scans and stores all documents that pertain to suppliers, and automatically notifies them when they are nearing the expiry dates for essential documents such as Tax Clearance, BEE certifications and other similar accreditations
- Allows for the black-listing of suppliers that do not deliver or perform to standard
- Enables suppliers to update their information directly through the supplier portal

Quotation Management

Simplify high-volume procurement based on the "Three Quotes System", from the initial request to the issuing of requests for quotations (RFQs), through to evaluation and the final issuing of an order.

- Allows end-users to submit requests and track progress of procurement online 24/7
- Enforces supplier rotation to ensure compliance with SCM policy
- Automatically excludes black-listed, non-compliant suppliers and nonresponsive suppliers from RFQs
- Generates and sends out RFQs by email and fax in a completely automated process
- Scans and stores all responses for future reference and full auditability of the process
- Prevents procurement when there is no available budget through integration with BAS
- Speeds up procurement turnaround times to assist line functions in the execution of their mandates
- Enables the analysis of procurement and spending patterns by commodity, supplier, region and functional unit

Bid Management

Get consistent and streamlined management of bid processes while adherening to Supply Chain Management (SCM) regulations.

- Co-ordinates the end-to-end bid process from initiation of procurement, to obtaining all the necessary approvals, finalising the Terms of Reference advertisement, bid evaluation (BEC), bid adjudication (BAC) to the final issuing of a letter of award. The system also allows for conditional award requirements
- Prevents initiation of bid process if funds are not available through integration with BAS
- Enforces compliance to policies and procedures through enforcement of mandatory supporting documentation, and archives documentation for future reference and auditability
- Provides visibility at all times of the Bid Management pipeline, measures progress, and helps identify bottlenecks in the Bid Management process

Travel Booking

Simplify and fast-track trip authorisation and booking processes.

- Captures travel requirements through a simple online form that automatically fills in traveller information and preferences
- Only completes a booking once the availability of budget has been checked and confirmed
- Automatically enforces the specified travel policy, such as travel class or car grouping
- Attaches all of the necessary motivations for supervisors and budget owners to expedite the process of obtaining their required approvals
- Simplifies the process by which users can obtain, revise and accept quotes from the Travel Agent
- Sends notifications to the traveller once the approvals have been completed and the booking made

Financial Management

Payments & Invoice Tracking

Speed up the payments process, increase compliance with National Treasury regulations that necessitates payments to be made within 30 days, and strengthen controls and accountability around all payments in the system.

- Scans and uploads invoices and supporting documents to ensure a completely electronic payments process
- Automates the Invoice to Order matching, the verification of budget availability and the verification of invoice amounts as a standard part of the invoice acceptance process
- Minimises the errors that arise from the recapture of order and invoice related information
- Enforces the end-user's accountability by requiring that evidence of delivery be attached to all invoices within the system before authorisation is granted
- Monitors the payment processes to ensure that pre-defined execution times, including compliance to the 30-day payment timeframe, are adhered to correctly and allows the source of any delays to be identified through detailed audit trails
- Notifies service providers automatically once an invoice has been accepted and once the payment has been captured onto BAS

Budget Reporting & Monitoring

Provides near real-time visibility of the departmental finances to all managers through easy to use reporting tools that enable more accurate financial management and planning. In addition, automate legislated reporting to make the financial reporting process almost effortless.

- Captures monthly and annual spending projections

Transforming Tswhane

City of Tswhane's old, lumbering workflow becomes a seamless stream of efficiency with Smartgov

Rich, informative and accurate Mayoral Committee Reports form the backbone of the decision-making processes at the City of Tshwane (COT). In spite of three attempts to automate the process in previous years it remained a paper-based activity that caused significant issues.

The challenges

- Inconsistent report flows that contravened guidelines as laid out in existing policies
- Delays in consultation processes with Metro departments
- Loss of reports
- Inability to monitor and enforce response times
- Inconsistent review and approval processes and lack of accountability
- Inconsistent reporting formats and quality
- Inability to track report changes through the approval chain
- Difficulty in monitoring progress and following up on reports
- Limited ability to produce meaningful statistics to manage the performance of the MayCo System
- Labour-intensive tracking and reporting of implementations of resolutions
- Excessive amounts of paper used

The solution

Boxfusion was engaged by COT to deliver a solution that would work seamlessly within the city.

A four month pilot was run based on a Smartgov solution that was specifically designed and developed for the automation of the Mayoral Committee Reports within local municipalities. This was such a success that COT rolled it out to all 22 of its departments covering approximately 1 000 users throughout the city.

This has resulted in the complete elimination of paper reports from the city. It has streamlined processes, improved productivity, allowed for greater accountability and assisted COT in delivering reports that allow for city-wide improvements and developments.

eSubmissions for the Eastern Cape

Smartgov streamlines the Department of Economic Development, Environmental Affairs and Tourism

The Department of Economic Development, Environmental Affairs and Tourism (DEDEAT) in the Eastern Cape is responsible for the transformation of the province's socio-economic landscape. Its role is pivotal in terms of supporting the current economy and growth of the region.

The challenge

DEDEAT was reliant on legacy paper-based services which had a significant negative impact on its ability to perform to standard and to deliver on mandates. The department suffered from lack of visibility in workflow progress, poor auditability, inability to consistently enforce policies and controls, long delays, lost requests and excessive administration costs.

The solution

We deployed our eSubmissions, eLeave, S&T Claims, Supplier Payments and Procurement modules within the department, all of which were required to address legacy issues and concerns.

The implementation was accompanied by a comprehensive Change Management campaign that was run across the department to support the workforce, and inspire them as they shifted to the new paperless way of working. Both Boxfusion and DEDEAT ensured that employees were made to feel comfortable with the new systems and how easy and intuitive they were to use.
